# **April Shareholder Update**

Dear Shareholders,

April was another big month for Capricorn Power, with the achievement of a significant product development milestone and the further addition of exceptional talent to our Board. We are very pleased to report that we signed a joint venture agreement with Ultima Grid Solutions (UGS) for a five-year \$20.1m R&D program to accelerate the development and commercialisation of our heat engine. In addition, we are delighted to announce that Vicki Tutungi, ex-CSIRO, serial entrepreneur and start-up executive, has joined the Capricorn Power Board.

These major operational milestones, together with the upcoming commissioning of our heat engine, lay the foundation for our forthcoming Birchal Crowd-Sourced Funding (CSF) raise. We will provide further details on the investment opportunity and how to invest in the next few weeks. We are excited about the journey ahead, and we hope you are too.

## Joint venture agreement with Ultima Grid Solutions (UGS) for \$20.1m R&D program

Ultima Grid Solutions (UGS) and Capricorn Power have confirmed a new joint venture project agreement on a detailed five-year, \$20.1M grid innovation program involving world-leading researchers from top universities across Australia. The project, subject to confirmation of program award, is working to boost renewable energy production in Australia. Capricorn Power's contribution is \$5M over five years, and we have confirmed 43.5% R&D eligibility on our contribution (net \$2.8M over five years) with our R&D advisors.

The project centres on Capricorn Power's core innovation, the Barton Heat Engine, which efficiently transforms waste heat into low-cost electricity with no emissions, water or chemicals. Capricorn Power, along with university researchers, will focus on further developing the Barton Heat Engine by improving efficiencies and power and lowering cost, and also integrating with a variety of heat sources, including Thermal Energy Storage. The project scope will build on learnings from our first commercial engine and involve manufacturing 4.0 principles, starting with the creation of a digital twin to fast track development.

UGS has brought the parties together and will manage the project, as well as leverage the work into commercial applications. Capricorn Power joins the UGS ecosystem of a domestic and international client base, all of which are focused on making significant changes in the energy sector.

Ultima Capital Partners, the parent company of UGS, is the major corporate partner for the RACE for 2030 — an initiative from the Australian Government through its Cooperative Research Centres — which aims to drive innovation for a secure, affordable, clean energy future. UGS originates, develops and funds research, development, prototyping and new technology trial and integration projects. A select few of these projects are chosen to participate in RACE for 2030.

UGS has significant project opportunities in local and overseas markets when the operating performance of the Barton Heat Engine has been validated by commissioning data.
